Preamble

Taking into consideration:

- The Subsidy Contract signed between the Commissariat Général à l'Égalité des Territoires acting as Managing Authority of the European Territorial Cooperation programme URBACT III, (assisted by the URBACT Secretariat) and the Lead Partner of the RetailLink on 30th September 2015.
- The Latest version of the Application Form of the project as approved by the URBACT III Monitoring Committee on 3rd May 2016;

The Subsidy Contract of the project shall be amended as follows:

Article 1 – Award of Subsidy

In accordance with the decision of the URBACT Monitoring Committee dated 11th September 2015 and subsequent decision for Phase 2 on 3rd May 2016, an earmarked subsidy is awarded to the Lead Partner of RetailLink (Ref Synergie-CTE N°215) from funds of the URBACT III Operational Programme for the maximum amount of:
